Whereas the **Founder** is desirous to establish Educational, Welfare and Charitable Trust for general welfare of humanity in memorial of his father. The Trustees at the request of **Founder** agreed to act as **Trustees** of these presents upon the terms and provisions hereinafter contained.

NOW THIS TRUST DEED WITNESSES AS FOLLOWS :

- (1) In order to effectuate the said object creating and establishing a Public Welfare and Charitable Trust , the **FOUNDER** has delivered to and made over to the Trustees a sum of Rs. 10 ,000 /= ( Ten Thousand only ) with intents to part with all his rights ,title and interest therein and vest the same in the Trustees to have and to hold the same and the investment or investments for the time being representing the same and or other properties that may for the time being represent the Trust Estate together with all additions and accretions thereto and all accumulated income thereof and all other property that may be acquired out of the same or othe wise may hereafter be subject to the Trust ( hereinafter referred to as The **TRUST FUND** ) for the

charitable objects and purpose and uses hereinafter expressed with the powers and on the terms and conditions herein contained of the concerning the same .

(2) **Name of the Trust :**

" TESH LAL SINGH EDUCATIONAL MEMORIAL TRUST "

(3) **Registered office of the Trust** :- The Registered office of the Trust shall be situated at - Piro , Near Vypar Mandal , P.O. & P.S. Piro District Bhojpur , Bihar PIN 802207 , which may be changed from time to time to such other place or places as the Trustees may deem fit and proper at their discretion.

(4) **Working Area** :- Working area of the Trust shall be all India .

(5) **Branch office** :- Branch office of Trust shall be opened in any place or places in all over India which may be decided by the meeting of Board of Trustees or managing committee of Trust.

(6) **Aims and objects of the Trust** :

The Aims and objects of the Trust is purely Charitable Purpose.

(i) For the establishment of schools and colleges which shall be opened for the students of all communities within the union of India and such other places as decided by the majority of the Trustees.

(ii) For running the Educational Institutions from Primary to Post Graduate and other Technical Education , the rules and regulations of which may be made by the Trust and to be established by the Trust . .

(iii) For running the Management college , Law college , B. Ed. College , Medical college , Engineering college etc. to be opened in accordance with the rules as may be made by the Trustees for the time being and also expanding its activities by the establishing other Educational , Technical , Industrial , Training and Professional; Institutions or organizations and to seek its affiliation from concerned authorities.

(iv) To seek affiliation / recognition of Schools, Colleges and Technical Institute established and administered by the Trust from Board, Universities, Councils and concerned authorities & offices

(v) To start, run and manage the various training centers like Poultry , Goatery , Piggery , Fishery etc. to train the young boys and girls belonging to the SC ,ST , Minority and Backward classes for the purpose of getting self employment and also for the solution of the problems of unemployment and also provide all necessary facilities to the trainees.

(vi) To start , establish , run , manage various Orphanage , Anath Ashram , Old Age Home , Children Home in all over India and where the board of Trustees may decide from time to time .

(vii) To organize meetings, seminars, discussions and press conferences to raise legal demands and fundamental rights provided by the Constitution of India.

(viii) To help the street children by providing them shelter , food and education.

(ix) To provide food, cloths , shelter , medicines and other required facilities to the people who have faced natural calamity and / or disaster.

(x) To follow the ideology of Great Men and National Leaders who sacrificed their lives for our nations .

(xi) To help the poor and indigent persons in marriage of their sons and daughters by way of cash donation or otherwise and to distribute cloths and food etc. for use of daily life of poor orphan and indigent persons .

(xii) To meet traveling , boarding and lodging expenses for students going aboard for higher education and also help them in all possible ways.

(xiii) To take effective , reasonable and lawful steps for the solution of the problems relating to the blind, handicapped , mentally disabled , deaf , dumb and other disabled through the various kind of training programs and also providing them required facilities to make them independent .

(xiv) To establish, maintain or grant aid for the establishment or maintenance of wells , tube - wells , tank , water reservoirs and also to make the construction & maintenance paths , roads and parks etc.

(xv) To create forum for Senior Citizens where they can exchange their various views and experiences which may be make available to younger generation.

(xvi) To approach the competent court of law to safeguard the rights of the general public interest as the Trust may deem fit and proper.

(xvii) To accept donations , grants , presents , gift and other offering in the shape of movable and / or immovable properties for the attainment of aims and objects of the Trust.

(xviii) To receive financial and non financial assistance from the Govt. , Non Govt. Organizations , International Agency , Banks and any other legal entity .

(xix) To invest the Trust fund in the various schemes for the purpose of raising funds of the Trust to spend the same for the fulfillment of objects of the Trust .

(xx) To purchase the land and building in the name of Trust for the upliftment and fulfillment of the aims and objects of the Trust .

(xxi) To sell , gift , lease and mortgage the Trust property for the attainment of aims and objects of the Trust .

(xxii) To assist and co - operate the others Trust , Societies and N.G.Os. whose aims and objects are like this Trust .

(xxiii) To open unit, sub office and branch of Trust in India .

(xxiv) To make rules and regulations for the control and management of Trust activities and to amend, vary or rescind them from time to time.

(xxv) To organize various kinds of children welfare programs and activities.

(xxvi) To pay govt. rent and tax as raised by concerned authority.

(xxvii) To perform work for charity for the general public .

(xxviii) To protect and support the interest of SC / ST, women , landless persons , bonded labourers and other disadvantaged sections of the society.

(xxix) To establish Hospital, Clinic, Health Centre and dispensaries for the public welfare.

(xxx) To do such others things / acts / activities which are necessary for the attainment of the aims and objects of the Trust .

(xxxi) The Trust will invest its money and funds according to the provisions of the Income Tax Act , 1961 and get registered under 80 - G of the Income Tax Act.

(7) **Board of Trustees / Office Bearers**

The numbers of Trustees shall not be less than **Three** and not more than **Eleven**.

**(8) Membership**

Membership of the Trust is open to any person who has attain the age of majority and fulfill the terms & conditions of the Trust as framed b Board of Trustees / Managing Committee .

**(9) Admission Fee and Subscription**

Admission fee and subscription shall unless otherwise revise by the Trust as framed by Board of Trustees / Managing Committee.

(a) Admission fee      Rs. 101 / = ( one hundred one only )

(b) Subscription      Rs. 120 / = ( one hundred twenty only ) per year

**(10) Type of Members**

At present there is only one type of members namely - General Member. Board of Trustees shall decide different type of members in its meeting called for this purpose.

**(11) Termination of Membership**

Board of Trustees shall have power to expel / terminate a member or members on the following grounds :-

- (a) on death
- (b) on written resignation
- (c) if convicted by any court of law or declared insolvent or unsound mind.
- (d) if disregard Rules & regulations of Trust or disobey the decision of Trust.

**(12) General Body**

All the members of the Trust shall constitute General Body . Meeting of General Body shall be organized once in every year regularly . Urgent General Body meeting shall be called by the Chairman at any time on his / her discretion . Quorum of General Body meeting shall be 2 / 3 ( two third ) of the total strength of General Members . Duties , Rights and Privileges of members shall be decided in General Body meeting. All the rules for conducting meeting shall be decided by the Chairman of the Trust.

**(13) Managing Committee**

In General Body meeting of Trust with consent of Trustees a Managing Committee of the Trust shall be constituted in supervision of Chairman of the Trust and managing committee shall following powers :-

- (a) The Managing committee may frame rules from time to time for the conduct of the administration of the Trust and regulating the meeting of the Trustees.
- (b) All the matter will be decided by the majority and the quorum for the meeting will be two third (2 / 3) of the trustees / managing committee.
- (c) Election of office bearers shall be conducted by the Managing Committee of the Trust after every **Five years**.
- (d) The Managing committee shall fix the remuneration of Trustees.
- (e) The Managing committee shall power to constitute sub - committee for the work of Trust.
- (f) The Managing Committee shall do all acts which are necessary of attainment of aims and objects of the Trust.

**(14) Meeting of the Board of Trust / Managing Committee**

- (i) Meeting of managing committee shall be organized at least three times in a year.

(ii) Urgent meeting may be called by the Chairman of the Trust at any time as per his / her discretion.

(iii) Quorum of managing committee meeting shall be 2 / 3 (two - third) of the total strength of Members of managing committee.

(iv). The managing Committee shall have power to revise, amend, alter and substitute the rules of the Trust for the fulfillment of aims and object of Trust.

(v). All the rules for conducting meeting of Trust shall be decided by the Chairman of the Trust

**(15) Powers and duties of Trustees / office bearers**


**(A) Chairman**

(i) The Chairman will be absolute in charge of the Trust and he /she will exercise all the discretionary powers for the Trust .The general management and control of the properties and its affairs shall be vested in the Chairman and Chairman shall have power to do the all such acts as may be considered necessary for the benefit and management of its property and affairs and attainment of aims and objects of the Trust. Veto power shall always remain with the Chairman.

(ii) In course of any proceedings or meetings of the Trust , the decision of the Chairman shall be considered final.

(iii) The Chairman shall sign all the papers / letters on behalf of the Trust and correspondence shall be in the name of Chairman.

(iv). The Chairman will ordinarily hold a cash balance not exceeding Rs. 5000/= (five thousand only) to meet the emergent needs of Trust.

(v) To do all such other legal steps to achieve the aims and objects of the Trust.

**(B) Secretary**

(i) The Secretary shall circulate the notice to concerned Trustees / Board of Trustees / Members of Managing Committee and General Members .

(ii) The Secretary shall prepare the membership register as well as the proceeding register to record the minutes of the proceeding of the meeting of managing committee and general body meetings and have them signed by the members who attend the meetings.


(iii) The Secretary shall do all such other work in the interest of Trust as instructed by the Chairman.

**(C) Treasurer**

(i) All the funds of the Trust shall remain under the care and management of Treasurer of the Trust and Treasurer shall maintain the accounts of income and expenditure of the Trust.

(ii) The Treasurer will ordinarily hold a cash balance not exceeding Rs. 5000/- ( Five thousand only ) to meet the emergent needs of the Trust.

(iii) All cash excess of the above amount or amount fixed by the managing committee shall be deposited in Bank account of Trust.

**(16) Source of Fund**

(a) Admission and Subscription fee

(b) Donations , Special contributions and Gifts

(c) Funds generated by Exhibitions , Functions , Seminars and other cultural programs arranged by the Trust .

**(17) Financial Year**

The financial year shall be 1<sup>st</sup> April to 31<sup>st</sup> March of every next year.

**(18) Management of Funds & Accounts**

Funds of the Trust will be maintained by the Treasurer and Account of Trust would be opened in Nationalize Bank or / and Post office. Bank or /and Post office account of Trust would be operated by joint signatures of the Chairman and Treasurer of the Trust.


**(19) Audit**

Fund of the Trust would be audited by qualified Accountant or Chartered Accountant in every year.

**(20)** The Board of Trustees shall be entitled to sue in the name of Trust and may similarly be sued in the name of Trust.

(21) The dissolution of the Trust may be decided in the meeting of managing committee of Trust and with consent of the Chairman of the Trust, there remains after the satisfaction of all its debts and liabilities, any property whatsoever the same shall not be paid or distributed among the members of the Trust although shall be given or transferred to some other like institutions having same aims and objects to be determined by managing committee at or before time of dissolution.
